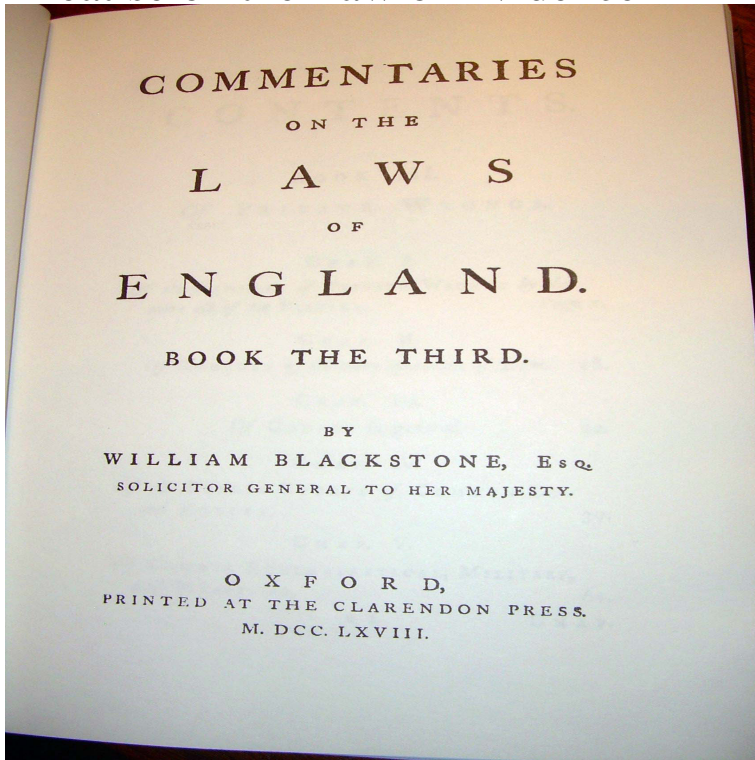


Treatise on the Law of Evidence
